<u>BC United Way/Madeline Partnership Affordable Housing Project</u> - Mr. Jones reported we have a Bond Ordinance that will be introduced next week regarding bonding for our Affordable Housing Project at the train station Parking lot. We bonded for 3 million, however he explained that number might change before next week's meeting as the cost of lumber has increased substantially during COVID.
