#### **PUBLIC DISCUSSION**

Mayor Randall opened the meeting to the public. He stated if anyone desired to be heard, please raise your hand to be recognized, and state your name and address for the record.

#### Patty Walker, 11 Sutton Drive

Ms. Walker had three on going issues of concerns; 1<sup>st</sup> issue she discussed was the water; regarding the increase in her water bill & the safety of the water. 2<sup>nd</sup> issue is her street, requesting to have her street repaved as there are many

potholes and she cannot repave her driveway until the street is done. Also; she is concerned about the safety for residents on the street since there is no street light. At one time there was a street light on the corner of Ackerman & Sutton however it was removed when PSE&G replaced the pole. She was told by Administrator Jones at that time everyone in the neighborhood would need to sign a petition and agree to a light, however there was one person who was not in favor and Ms. Walker asked why can't they get a light someplace else on the block. 3<sup>rd</sup> issue – two weeks ago it was found on a neighbor's doorbell camera that an employee of the garbage company was urinating on her bushes. She asked for people to just do better.

Mayor responded; thank you for coming and sharing your concerns, he shares the same concerns regarding the garbage issues. He explained they are not happy either and they are working on rectifying the situation. The issue on the light, we have a long standard policy that you do get the consent of neighbors to put a light in a certain area. He suggests reaching out to PSE&G for another location and start the process again, himself & the council would support another street light. Regarding the paving, we have our DPW assess the street on a number of matrix including how much usage, we only have a limited amount of streets we can do every year. Regarding the water, as far as the quality of the water, the borough has been very proactive in terms of getting our filtration system in place and is tested better than most of the area. We take this very seriously and we are proud of our water system and we are the process of trying to get that next phase in getting those containment's out of the water.

Administrator Jones responded as well; regarding the water issue – as far as the letter that is sent out to residents, the language is dictated by the State and it's been the same letter since the beginning of the process. The borough started the Water Filtration System process back in 2019 with the goal of have it completed by 2020. The NJDEP offices are still working from home and held our project up approximately 18/24 months. We remain the number 2 project in the State que out of 570 municipalities. February 10<sup>th</sup>, we are out to bid as we finally got the approval we have been waiting for over two years. We have our bid opening on March 10<sup>th</sup> where we hope to award the contract at our March 14<sup>th</sup> meeting. Expecting a six month delay on getting the necessary equipment, however, our permit has been extended to the end of this year. Once this project is complete all the containments will be brought down to zero. As far as your concern for the increase in your water rates, that is to off-set this project as it started out as a million dollar project it is now a 4 million dollar project. However, during the summer when residents were complaining about their high water bills, it was found that the homeowners were over watering or a leak was undetected, or a toilet was running and the data logs that were done prove that.

Administrator Jones addressed the paving issues and explained the process of how they decided what streets get paved in any given year. The Police, DPW & Residents give us streets they feel are in need of work. Then the Engineer goes out and evaluates them to see what needs the most repairs. At which time we budget the money to see as far as we can go. After they finalize this year's list, he will let Ms. Walker know if her street will be one of the ones that get repaved.

#### Carol Tyler, 1 Stouts Lane

Ms. Tyler thanked the Mayor & Council for the attention to VIP (Volunteer Incentive Program) it is very much appreciated.

## Dennis Branca, 18 Saddle Ridge Road

Ms. Branca discussed the volunteer organizations and asked the Mayor & Council to asked themselves what they can do to continue to create a bridge to bring people together in unity and help restore relationships. Ms. Branca also expressed her displeasure on what happened at the Woodlands adjacent to Saddle River Road property where they clear cut all those trees. She would like the town to established a preservation of our beautiful trees. Ms. Branca quested what are the qualifications needed to be on the Shade Tree/Beautification Committee & she asked for Mayor & Council to define Commission vs. Committee. Lastly, she asked if the pending issues with the Fire Department has been resolved. Mayor suggested she email her listed of questions and he would address them. Administrator Jones added we do have a borough arborist (who is a certified tree expert) who handles all inspections and has the final say the matter of concerns, which has improved communication with our residents. All former members of the shade tree were offered membership to the newly formed Shade Tree/Beautification Committee, which some members decided to join. The concerns regarding the heritage trees & clear cutting in a development is going to be addressed,

we expect to introduce an ordinance next month. Mayor Randall added the difference between a committee and a commission is a committee there is better oversite because a committee deals directly with the town as opposed to the commission which operates independently. Regarding the Fire Department our position is the matter has been concluded and we are working on getting our relationship back on track.

#### Karen Zatorski, 45 Wearimus Road

Ms. Zatorski stated her question is about communication, she questioned whether the meeting is being recorded and when are the minutes posted, she suggested posting the agenda of the meeting on the website. Borough Clerk responded the meetings are always being recorded and minutes are posted on the website once they are approved by the Mayor & Council. The Agenda of all meetings is always posted on the website before the meeting. Ms. Herve also stated the minutes is not a transcript, meeting minutes summarize the key issues discussed and will note any action taken. Ms. Zatorski suggest the Mayor & Council post the things that they are proud of on the website (such as the purchase of the Bank of American Building) and on the borough's social media sites as that is where most people look for information. Attorney Tim Wiss stated we a government agency and we are govern by where we have to publish certain information which is the official newspaper of the borough. The reason we do not use Facebook or other social media sites is it not an appropriate legal avenue for publishing. Ms. Zatorski added she feels the Mayor & Council can do better communicating. She also questioned what is happening with Bank of American Building & the Library. Mayor responded stating there was a public meeting and we were encouraged to move forward with the focus on moving the library to that location.

#### Richard Branca, 18 Saddle Ridge Road

Mr. Branca also expressed his displeasure with the clear cutting of trees and questioned if a construction official has the power to request from a developer to leave certain amount a trees alone. Mayor responded there are certain things that can be done with the contexts of a subdivision, however if someone has a conforming lot that person has the right to cut down the trees they want. Attorney Wiss added one of the reason the change from a Commission to a Committee is to more accountable and pass more legislation to stop the issues the residents are concerned about.

#### Patty Walker, 11 Sutton Drive

Ms. Walker feels the integrity of the town went downhill for what we are allowing to build on these properties. She asked is there any way of preserving what makes Ho-Ho-Kus a special town. Mayor stated that it may be the people moving-in does not share the same appreciation for the town as we did when we all came here and they have own vision on want to do with their property. He does want to see the town preserved, however legally we can only go to a certain point.

## AN ORDINANCE TO ACQUIRE BLOCK 1014, LOT 3, COMMONLY KNOWN AS 620 CLIFF STREET FROM VETERANS OF FOREIGN WARS IN ACCORDANCE WITH N.J.S.A. 40A:12-5.

**WHEREAS**, the Veterans of Foreign Wars ("VFW") is the fee simple owner of real property known as Block 1014, Lot 3 a.k.a. 620 Cliff Street and which piece of said real property is about to be conveyed to the Borough of Ho-Ho-Kus: and

**WHEREAS**, a contract for the purchase of the subject premises has been negotiated and prepared and is now ready for execution by the proper Borough Officials; and

**WHEREAS**, a copy of the proposed contract of sale is on file with the Borough Clerk and same is available for public inspection during the normal business hours of the Borough of Ho-Ho-Kus; and

**WHEREAS**, the Borough of Ho-Ho-Kus desires to acquire part of the subject premises in accordance with the provisions set forth in N.J.S.A. 40A:12-5; and

**WHEREAS**, the laws of the State of New Jersey permit a municipality by ordinance to authorize the acquisition of private and/or public property by purchase and/or gift.

WHEREAS, the Borough of Ho-Ho-Kus wishes to ratify the actions of the Borough Officials in negotiating the contract to acquire the subject property;

NOW THEREFORE BE IT ORDAINED and enacted by the Mayor and Council of the Borough of Ho-Ho-Kus as follows:

- 1. The Mayor, Clerk and Borough Attorney are hereby authorized to execute any and all necessary documents in order to acquire the said real property;
- 2. The actions of the Borough Officials in negotiating the subject contract are hereby ratified;
- 3. The Borough shall accept an appropriate Deed and such other documents as may be reasonably required to acquire marketable Title in accordance with this ordinance.
- 4. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.
- 5. If any part, sections, provisions, or the total of any of the abovementioned publications are held to be invalid or unenforceable by any court, the findings or judgments of which court are applicable in the State of New Jersey, that the balance and remainder of such publication shall remain in full force and effect as an Ordinance of the Borough of Ho-Ho-Kus.

This Ordinance shall become effective immediately upon adoption and publication according to law.

## INTRODUCTION OF ORDINANCES

## ORDINANCE #2023-80

## AN ORDINANCE TO AMEND CERTAIN PORTIONS OF CHAPTER 3 OF CODE OF THE BOROUGH OF HO-HO-KUS

**WHEREAS**, the Mayor and Council of the Borough of Ho-Ho-Kus believes it is in the best interest of the residents of the Borough to repeal Section 3-5 of the Code of the Borough of Ho-Ho-Kus and replace it with a more streamlined process, which still provides for notice and an opportunity to be heard to an accused member or officer;

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Ho-Ho-Kus that Chapter 3-5 of the Code is hereby amended as follows (deletions in strikethrough and additions in **bold**):

Chapter 3-5 is deleted in its entirety and replaced as follows:

- § 3-5 Suspension or expulsion of members or officers.
- A. In addition to such disciplinary process as may be provided under the Volunteer Ambulance Corp's bylaws, and notwithstanding the same, any Ambulance Liaison of the Borough of Ho-Ho-Kus shall have the right to expel or suspend any member or line officer as set forth below.
- B. In event of any accusation of any allegation of misconduct, violation of Borough Ordinance, or action effecting the health, safety or welfare of the residents of the Borough of Ho-Ho-Kus by any member or officer, any person may issue a written complaint, which shall be referred to any Ambulance Liaison or his designee. Such Ambulance Liaison shall consult with any other Ambulance Liaison, and such Liaisons shall review the matter and may proffer charges against such member seeking the members expulsion or removal. In the event of a tie or disagreement between the Liaisons, the Mayor shall have the ability to break the tie.
- C. Upon proffering such charges, the Ambulance Liaisons shall provide such member or officer with notice of the charges and an opportunity to provide a written response to the charges. The Ambulance Liaisons shall thereafter recommend sustaining, not sustaining, or modifying the charges, without a further hearing. Any member or officer shall have no greater rights than an "at-will" non-paid volunteer and nothing herein shall be read to provide any greater rights to such member or officer. In the event of a tie or disagreement between the Liaisons, the Mayor shall have the ability to break the tie.
- D. If any charges are sustained or modified, the Ambulance Liaisons shall inform the Borough Council, which shall determine whether to suspend or expel such member or officer from the Ambulance Corps or take such other action as it deems appropriate, without a further hearing.
- E. Notwithstanding the above, any Ambulance Liaison, acting alone, may immediately suspend any member or line officer prior to receiving the member's written response should he or she deem such suspension in the best interest for the health, safety, and welfare of the residents of the Borough of Ho-Ho-Kus.
- F. In the event of any conflict between the Ambulance Corp's By-laws and this Chapter, the provisions of this Chapter shall control.

All other sections not heretofore amended shall remain in full force and effect.

#### SECTION II: Repealer.

All other ordinances of the Borough, or parts thereof, which are in conflict with this ordinance, are hereby repealed to the extent of such conflict.

## SECTION III: Severability,

The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

#### **SECTION IV:** Effective Date.

This ordinance shall take effect upon passage and publication as required by law.
