ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

(N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 1.0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the <u>Mayor and Council</u> of the <u>Borough of Ho-Ho-Kus (the "Borough")</u> in the County of <u>Bergen</u> finds it advisable and necessary to increase its CY 2021 budget by up to <u>3.5%</u> over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the <u>Mayor and Council</u> hereby determines that a <u>2.5%</u> increase in the budget for said year, amounting to <u>\$171,030</u> in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the <u>Mayor and Council</u> hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the <u>Mayor and Council</u> of the <u>Borough</u>, in the County of <u>Bergen</u>, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2021 budget year, the final appropriations of the Borough shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to <u>\$239,442</u>, and that the CY 2021 municipal budget for the Borough be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

ORDINANCE 2021-47

COUNCILMEMBER POLICASTRO: moved the Ordinance on second reading by title only

COUNCILMEMBER MORAN: Seconded.
ROLL CALL VOTE: All present voting "Aye"

AN ORDINANCE TO AMEND AND SUPPLEMENT ARTICLE V, CHAPTER 85, ZONING OF THE BOROUGH OF HO-HO-KUS SO AS TO CLARITY REQUIREMENTS FOR CERTAIN POOL CABANA ACCESSORY STRUCTURES

WHEREAS, the Borough's policy is to maintain the established residential character and scale of the R-1, R-2, and R-3 districts and to promote development that is in character and scale with the established neighborhoods and supported by the Borough's Master Plan; and

WHEREAS, the borough seeks to limit the overbuilding of residential principal and accessory structures that are out of scale with their neighborhoods by appropriate development regulations; and

WHEREAS, to further the goal of promoting the appropriate character and scale of structures in residential zones, including accessory structures, some amendments to the zoning ordinance are reasonable and appropriate.

BE IT ORDAINED by the Mayor and Council of the Borough of Ho-Ho-Kus, in the County of Bergen and State of New Jersey, that Article V section §85-15.1 entitled "Accessory buildings and structures" hereby amending and supplemented the existing code in the following particulars only: (deleted sections are noted by strikethroughs, new sections are underlined)

Section 1. Amend section §85-15.1, by amending to add the following:

- F. Accessory pool cabana. Pool cabana structures shall be subject to the following:
 - (1) An accessory pool cabana is permitted to be a one-story, ground level, detached accessory structure enclosed with a roof, serving a lawfully existing and approved inground swimming pool on a residential property.
 - (2) Only one accessory pool cabana is permitted per residential property.
 - (3) Such a structure shall be used only for recreational or storage purposes associated with the principal residential use of the property.
 - (4) The pool cabana structure shall not contain a bedroom and/or similar living quarters and shall not contain such accommodations to be defined as having a full service kitchen. A toilet, sink and exterior (only) shower are permitted.
 - (5) In addition, a cabana shall comply with the following maximum dimensions:

Lot Size (square feet)	Maximum Cabana Size (square feet)
6,500 to 22,000	150
22,001 to 43,000	200
43,001 and greater	300

- (6) A deed restriction containing the following language is to be filed with the Bergen County Clerk's Office for the property containing the accessory pool cabana stating minimally the following:

 The grantor and grantee specifically represent and warrant that this deed contains a Deed Restriction whereby the cabana use will not contain, bedrooms and/or living quarters, full service kitchen or used for sleeping. This deed restriction is intended to prohibit conversion to a habitable space.
- (7) Pool cabanas shall conform to the accessory structure setback and coverage requirements as set for the in the zone and in Section 85-15.1 herein.

<u>Section 2</u>. Amend section §85-7 B. by amending to add the following definition:

FULL SERVICE KITCHEN

A full-service kitchen includes an indoor area for food preparation containing a stove or range.

<u>Section 3</u>. If any section, subsection, paragraph, sentence or any other part of this ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this ordinance.

<u>Section 4</u>. All ordinances or parts of ordinances which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

Section 5. The Borough Clerk is hereby directed to give notice at least ten (10) days prior to the hearing on the adoption of this ordinance to the Bergen County Planning Board, and to all others entitled thereto pursuant to the provisions of N.J.S.A. 40:55D-15. Upon adoption of this ordinance, after public hearing thereon, the Borough clerk is further directed to publish notice of the passage thereof and to file copy of this ordinance as finally adopted with the Bergen County Planning Board as required by N.J.S.A. 40:55D-16 and with the Borough Tax Assessor.

Section 6. This ordinance shall take effect twenty (20) days after final passage and publication as prescribed by law.

ORDINANCE 2021-48

COUNCILMEMBER MORAN: moved the Ordinance on second reading by title only

COUNCILMEMBER CROSSLEY: Seconded. ROLL CALL VOTE: All present voting "Aye"

"AN ORDINANCE TO AMEND AND CLARIFY SECTION 77.7 OF ARTICLE III, CHAPTER 77 OF THE CODE ENTITLED "UNIFORM CONSTRUCTION CODE DEPARTMENT" WITH RESPECT TO LARGE OPEN VOLUME CONSTRUCTION PERMIT FEES

WHEREAS, the Borough of Ho-Ho-Kus has heretofore adopted Chapter 77.7 of the Code of the Borough of Ho-Ho-Kus; and

WHEREAS, the Borough of Ho-Ho-Kus wishes to amend Chapter 77.7 (A)(1) so as to add sub-section (b) which clarifies the construction permit fees for large, open volume buildings

BE IT ORDAINED by the Mayor and council of the Borough of Ho-Ho-Kus, County of Bergen and State of New Jersey as follows:

SECTION I

Chapter 77.7 (A)(1) of the Code is hereby amended by inclusion of a new subsection (b) as follows:

SECTION 77.7

Fee for a Construction Permit

The fees and charges required under the code of the Borough of Ho-Ho-Jus entitled Construction Codes, Uniform, shall be as follows (new section is in *italics* below):

A. The fee for a construction permit shall be the sum of the subcode fees listed in paragraphs a.,1. Through 10. Thereof, and shall be paid before the permit is issued.

(1) New construction and additions are based on the volume of structure:

- (a) Volume of building in cubic feet x \$0.07.
- (b) Fees for new construction of large, open-volume, single story spaces, such as barns, silos, greenhouses, warehouses, distribution centers, and other agricultural, and storage-use occupancies, the fee shall be based on volume and use groups as follows:
 - (1) for uses A1, A2, A3, A4, A5, F1, F2, S1, and S2: \$.021 per cubic foot.
- (2) for the purpose of calculating the volume to determine the fee for these spaces as defined under subsection(b)(1) above, the height shall be limited to 20 feet notwithstanding the fact that the actual height of the space may be greater than 20 feet. However, the minimum fee shall be not less than \$40.

Section II Severability

If any section, sentence or any other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not effect, impair, or invalidate the remainder of this Ordinance but shall be confined in its effect to the section, sentence or other part of this Ordinance directly involved in the controversy which such judgment shall be rendered.

Section III Inconsistent Ordinances Repealed.

All ordinances or parts or ordinances which are inconsistent with the provisions of ordinance are hereby repealed, but only to the extent of such inconsistencies.

Section IV Effective Date.

This Ordinance shall take effect immediately upon final passage and publication as provided by law.

Section V

The Borough Clerk is hereby directed to give notice at least ten (10) days prior to the hearing on the adoption of this ordinance to the Bergen County Planning Board, and to all others entitled thereto pursuant to the provisions of N.J.S.A. 40:55D-15. Upon adoption of this ordinance, after public hearing thereon, the Borough clerk is further directed to publish notice of the passage thereof and to file copy of this ordinance as finally adopted with the Bergen County Planning Board as required by N.J.S.A. 40:55D-16 and with the Borough Tax Assessor.

AN ORDINANCE AUTHORIZING THE ACCEPTANCE, CONVEYANCE AND MODIFICATION OF A DRAINAGE EASEMENT LOCATED AT BLOCK 905, LOT 3, 40 DEERHILL DRIVE

WHEREAS, N.J.S.A. 40A:12-4 authorizes a municipality to acquire easements; and

WHEREAS, N.J.S.A. 40A:12-5 permits a municipality to convey easements by Ordinance; and

WHEREAS, through consultation with the Borough's engineering consultants, Schwanewede/Hals Engineering, the Borough has determined that an improved stormwater management system would be better facilitated by replacing the existing easement on the property located at 40 Deerhill Drive with a modified easement on the same property; and WHEREAS, the Borough previously granted a soil moving permit to the property owners of 40 Deerhill Drive by Resolution dated October 25, 2005 for the purpose of installation of an improve stormwater management system; WHEREAS, based upon the goal of mitigating the impact of stormwater in the area and mitigating the risk of flooding due to the presence of stormwater in the area and in consultation with the Borough's consulting engineers, the Borough has identified the located the modified easements as set forth in the "Deed of Easement" attached hereto, and the terms of which are incorporated herein;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council that the Borough is hereby authorized to convey the Deed of Easement aforesaid under the terms and conditions set forth herein/

After all requirements respecting the enactment of this Ordinance have been fulfilled and the aforesaid metes and bounds description and survey prepared by Conklin Associates dates March 8, 2021, revised March 16, 2021 and the Easement shall be recorded in the Office of the Bergen County Clerk.

- 2. Having passed a first reading, this Ordinance shall be published in the manner required by N.J.S.A. 40:49-6, at least once not less than ten (10) days prior to the time fixed for further consideration for final passage.
- 3. Pursuant to N.J.S.A. 40:49-6, at least one week prior to the time fixed for final passage, a copy of the Ordinance, together with notice of the introduction, including time and place fixed for final passage, shall be mailed to every person whose land may be affected by the Ordinance.
- 4. The Clerk shall, within sixty (60) days after the Ordinance becomes effective, file a Certified Copy thereof, under seal of the Borough of Ho-Ho-Kus, together with a copy of proof of publication thereof, in the Office of the Clerk of Bergen County, pursuant to N.J.S.A. 40:67-21
- 5. The Mayor, the Borough Attorney, and the Administrator are authorized to execute any and all instruments, or take such other action necessary to effectuate the purposes hereof.
- 6. This ordinance shall take effect after final passage and publication as provided by law

ORDINANCE 2021-50

COUNCILMEMBER CROSSLEY: moved the Ordinance on first reading by title only

COUNCILMEMBER MORAN: Seconded. ROLL CALL VOTE: All present voting "Aye"

CAPITAL ORDINANCE TO AUTHORIZE THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS IN, BY AND FOR THE BOROUGH OF HO-HO-KUS, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY AND TO APPROPRIATE THE SUM OF \$595,000 FROM VARIOUS GRANTS AND FROM THE CAPITAL IMPROVEMENT FUND TO PAY THE COST THEREOF.

BE IT ORDAINED by the Borough Council of the Borough of Ho-Ho-Kus, in the County of Bergen, State of New Jersey, as follows:

Section 1. The Borough of Ho-Ho-Kus, in the County of Bergen, State of New Jersey (the "Borough") is hereby authorized to make various public improvements in, by and for said Borough, as more particularly described in Section 4 hereof. The cost of the improvements includes all work, materials and appurtenances necessary and suitable therefor.

Section 2. There is hereby appropriated to the payment of the cost of making the improvements described in Sections 1 and 4 hereof (hereinafter referred to as "purposes"), the respective amounts of money hereinafter

stated as the appropriation for said respective purposes. Said appropriation shall be met from the various grants and amounts in the Capital Improvement Fund appropriated by this ordinance. Said improvements shall be made as general improvements and no part of the cost thereof shall be assessed against property specially benefited.

Section 3. It is hereby determined and stated that the making of such improvements is not a current expense of said Borough.

The several purposes hereby authorized are set forth in the following "Schedule of Section 4. Improvements, Purposes and Amounts" which schedule also shows (1) the amount of the appropriation and the estimated cost of each such purpose, and (2) the amount of each sum which is to be provided by the various grants hereinafter appropriated, and (3) the amount of each sum which is to be provided by the appropriation from the Capital Improvement Fund hereinafter made, and (4) the period of usefulness of each such purpose, according to its reasonable life:

SCHEDULE OF IMPROVEMENTS, PURPOSES AND AMOUNTS

A. Undertaking of the following infrastructure improvements: (i) resurfacing of Brookside Avenue (from N. Maple Avenue to the vicinity of First Street, and a portion of the municipal parking lot) (including curb and drainage improvements, where necessary); and (ii) resurfacing of various roads in the Borough (including curb and drainage improvements, where necessary) as the 2021 Road Resurfacing Program, as set forth on a list on file or to be placed on file with the Borough Clerk, and hereby approved as if set forth herein in full. Depending upon the contract price and other exigent circumstances, and upon approval by the Borough Council, there may be additions to or deletions from the list referred to in clause (ii) of the preceding sentence.

Section 5. The sum of \$390,654 is hereby appropriated from the Capital Improvement Fund to the payment of the cost of the purposes authorized in Section 4 above.

Section 6. The sum of \$144,346 received or to be received as a grant from the State of New Jersey Department of Transportation is hereby appropriated to the payment of the cost of the improvement of Brookside Avenue authorized in Section 4.A above.

Section 7. The sum of \$60,000 received or to be received as a grant from the County of Bergen Open Space, Recreation, Floodplain Protection, Farmland and Historic Preservation Trust Fund is hereby appropriated to the payment of the cost of the replacement of the North Field footbridge authorized in Section 4.B above.

The capital budget is hereby amended to conform with the provisions of this Section 8. ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

> Section 9. This ordinance shall take effect at the time and in the manner provided by law.

ORDINANCE 2021-51

COUNCILMEMBER CROSSLEY: moved the Ordinance on first reading by title only

COUNCILMEMBER MORAN: Seconded.
ROLL CALL VOTE: All present voting "Ave"

BOND ORDINANCE TO AUTHORIZE THE ACQUISITION OF A REVERSIONARY INTEREST IN REAL PROPERTY IN, BY AND FOR THE BOROUGH OF HO-HO-KUS, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$315,000 TO PAY THE COST THEREOF, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS.

BE IT ORDAINED by the Borough Council of the Borough of Ho-Ho-Kus, in the County of Bergen, State of New Jersey, as follows:

Section 1. The Borough of Ho-Ho-Kus, in the County of Bergen, State of New Jersey (the "Borough"), is hereby authorized to acquire a reversionary interest in real property in, by and for the Borough. Said improvement shall include real estate transaction expenses and all work, materials and appurtenances necessary and suitable therefor. The reversionary interest to be acquired is in real property with a street address of 91 Warren Avenue (and as described in the vesting deed from Hester Van Buiten to the Borough of Ho-Ho-Kus dated October 23, 1985 filed in Book 6968, Pages 633-635 on file with the Bergen County Clerk).

Section 2. The sum of \$315,000 is hereby appropriated to the payment of the cost of making the improvement described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be met from the proceeds of the sale of the bonds authorized and the down payment appropriated by this ordinance. Said improvement shall be made as a general improvement and no part of the cost thereof shall be assessed against property specially benefitted.

Section 3. It is hereby determined and stated that (1) said purpose is not a current expense of the Borough, and (2) it is necessary to finance said purpose by the issuance of obligations of the Borough pursuant to the Local Bond Law (Chapter 2 of Title 40A of the New Jersey Statutes Annotated, as amended; the "Local Bond Law"), and (3) the estimated cost of said purpose is \$315,000, and (4) \$15,000 of said sum is to be provided by the down payment hereinafter appropriated to finance said purpose, and (5) the estimated maximum amount of bonds or notes necessary to be issued for said purpose is \$300,000, and (6) the cost of such purpose, as hereinbefore stated, includes the aggregate amount of \$15,000, which is estimated to be necessary to finance the cost of such purpose, including architect's fees, accounting, engineering and inspection costs, legal expenses and other expenses, including interest on such obligations to the extent permitted by Section 20 of the Local Bond Law.

Section 4. It is hereby determined and stated that moneys exceeding \$15,000, appropriated for down payments on capital improvements or for the capital improvement fund in budgets heretofore adopted for the Borough, are now available to finance said purpose. The sum of \$15,000 is hereby appropriated from such moneys to the payment of the cost of said purpose.

Section 5. To finance said purpose, bonds of the Borough of an aggregate principal amount not exceeding \$300,000 are hereby authorized to be issued pursuant to the Local Bond Law. Said bonds shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law. All matters with respect to said bonds not determined by this ordinance shall be determined by resolutions to be hereafter adopted.

Section 6. To finance said purpose, bond anticipation notes of the Borough of an aggregate principal amount not exceeding \$300,000 are hereby authorized to be issued pursuant to the Local Bond Law in anticipation of the issuance of said bonds. In the event that bonds are issued pursuant to this ordinance, the aggregate amount of notes hereby authorized to be issued shall be reduced by an amount equal to the principal amount of the bonds so issued. If the aggregate amount of outstanding bonds and notes issued pursuant to this ordinance shall at any time exceed the sum first mentioned in this section, the moneys raised by the issuance of said bonds shall, to not less than the amount of such excess, be applied to the payment of such notes then outstanding.

Section 7. Each bond anticipation note issued pursuant to this ordinance shall be dated on or about the date of its issuance, shall be payable not more than one year from its date, shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law and may be renewed from time to time pursuant to and

within the limitations prescribed by the Local Bond Law. Each of said bond anticipation notes shall be signed by the Mayor and by a financial officer and shall be under the seal of the Borough and attested by the Borough Clerk or Deputy Borough Clerk. Said officers are hereby authorized to execute said notes in such form as they may adopt in conformity with law. The power to determine any matters with respect to said notes not determined by this ordinance, and also the power to sell said notes, is hereby delegated to the Chief Financial Officer who is hereby authorized to sell said notes either at one time or from time to time in the manner provided by law.

Section 8. It is hereby determined and declared that the period of usefulness of said purpose, according to its reasonable life, is a period of forty years computed from the date of said bonds.

Section 9. It is hereby determined and stated that the Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the office of the Borough Clerk of the Borough, and that such statement so filed shows that the gross debt of the Borough, as defined in Section 43 of the Local Bond Law, is increased by this ordinance by \$300,000 and that the issuance of the bonds and notes authorized by this ordinance will be within all debt limitations prescribed by said Local Bond Law.

Section 10. Any funds received from private parties, the County of Bergen, the State of New Jersey or any of their agencies or any funds received from the United States of America or any of its agencies in aid of such purpose shall be applied to the payment of the cost of such purpose, or, if bond anticipation notes have been issued, to the payment of the bond anticipation notes, and the amount of bonds authorized for such purpose shall be reduced accordingly.

Section 11. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

Section 12. The Borough intends to issue the bonds or notes to finance the cost of the improvement described in Section 1 of this bond ordinance. If the Borough incurs such costs prior to the issuance of such bonds or notes, the Borough hereby states its reasonable expectation to reimburse itself for such expenditures with the proceeds of such bonds or notes in the maximum principal amount of bonds or notes authorized by this bond ordinance.

Section 13. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and interest on the obligations authorized by this ordinance. Said obligations shall be direct, unlimited and general obligations of the Borough, and the Borough shall levy <u>ad valorem</u> taxes upon all the taxable real property within the Borough for the payment of the principal of and interest on such bonds and notes, without limitation as to rate or amount.

Section 14. This ordinance shall take effect twenty days after the first publication thereof after final passage.
