#### **Unfinished Business**

<u>BC United Way/Madeline Partnership Affordable Housing Project:</u> - Project continues, schedule date of completion sometime in the beginning of the new year.

<u>HHK Crossing Project</u> – Hearing for this project will be scheduled in the near future.

<u>Water Tanks Project</u> – All documents have been sent to the Local Finance Board; our application is scheduled to be reviewed at their October 20, 2021 meeting.

<u>Water Treatment System</u> – We are close to final approvals we need for our Water Treatment System. The borough received a notice that one of our wells are above the normal PFC levels. Administrator will notify the residents with a lengthy explanation as to what it is and what the borough is doing about it.

<u>ADA Handicap Restrooms(2<sup>nd</sup> Floor Municipal Building)</u> – Project scheduled to start next week. The lowest bid was \$93,000; however, the borough received a \$70,000 grant to off-set the funding for this project.

#### **New Business**

<u>Water Infiltration System Project</u> - The Borough is in the process of getting a loan to fund this project. The cost is approximately 2 million, however approximately 50% will be forgiven.

Below are the two projects that the Borough will be going out to bid before the end of the year:

- 1. The Bridge replacement at Northfield, where the Borough received a Community Development Grant in the amount of \$60,000 to fund this project
- 2. Paving Brookside Avenue up at the train station, where the borough received DOT Grant in the amount of \$144,346.00 to fund this project.

Mr. Jones also reported we are in the process of applying for a grant for repaving West Saddle River Road.

<u>Budget</u> – The process will begin in the next few weeks. Letters will be sent out to all department heads beginning October.

<u>Storm update</u> – Regarding Hurricane IDA 12 homes had to be evacuated. The DPW worked around the clock to remove the two pumps at the Bogert Station. They got the motors in, out and repaired in less than a week. Not one resident got sewage in their homes as a result of this which means the by-pass system works. Will have a full report at next week's meeting.

# **Borough Attorney Timothy Wiss Report:**

Mr. Wiss updated the Mayor and Council on the purchase of the Bank of America building. He stated the next step is to hire an environmental consultant to monitor the site. Once that is completed he is looking to close at the end of year end. Administrator Jones added there are no environmental concerns that we are aware of, this is just procedural.
