Proposed Ordinance Review:

Bond Ordinance No. 2021-42: Bond ordinance to authorize the making of a grant for the development and construction of affordable housing in, by and for the borough of Ho-Ho-Kus, in the County of Bergen, State of New Jersey, to appropriate the sum of \$3,150,000 to pay the cost thereof, to make a down payment, to authorize the issuance of bonds to finance such appropriation and to provide for the issuance of bond anticipation notes in anticipation of the issuance of such bond.

Mr. Cucchiara: stated the Board approved the Brookside application in 2019; the review of the Board Ordinance has been sent to the Board by the Mayor & Council; the Board is involved in the entire process of approval due to the significant affordable housing opportunities; the Board is to determine if the proposed ordinance meets with the goals and objectives of the Master Plan and amendment.

Ms. Wilkomm: inquired about any other outstanding Borough debt.

Mr. Jones: stated the Borough does have other debts due to various projects; this is a separate bond for the payment of the affordable housing project; it is the Borough's responsibility due to the lawsuit; it is a court ordered obligation.
