Ordinance No. 2021-60 adopting the Redevelopment Plan entitled "619 N. Maple Avenue, 217 & 239 First Street Development Plan" dated July 12, 2021; Pursuant to the Local Redevelopment and Housing Law N.J.S.A 40A:12A-1 et seq.
